1. General provisions

1. This document defines the terms of the Academic / Teaching Licence for the use of publications of the Report K* series and other publications made available by the Sir Roger Penrose Institute for Interdisciplinary Sciences.
2. The Academic / Teaching Licence is intended for universities, academic units, lecturers, course instructors, seminars, courses, doctoral schools, student research circles, educational units, research institutes and other entities conducting teaching, academic, scientific or educational activities.
3. The Academic / Teaching Licence authorises the use of publications in academic and teaching activities within the scope defined in this document, the offer description, the order or an individual decision of the Institute.
4. The Academic / Teaching Licence may apply in particular to:
 - a) a single regular volume of the Report K* series,
 - b) a single special volume of the Report K* series,
 - c) an analytical monograph published by the Institute,
 - d) a methodological report,
 - e) a printed edition,
 - f) a digital publication made available on terms agreed with the Institute,
 - g) an academic or teaching access package,
 - h) an academic or teaching subscription, if provided for in the Institute's offer.
5. The Academic / Teaching Licence does not transfer to the Licensee any economic copyrights to the publication or any intellectual property rights to the methodology, analytical structure, models, concepts, forecasts, charts, tables, diagrams, studies or other elements of the publication protected by law.
6. The Academic / Teaching Licence is non-exclusive, non-transferable, non-sublicensable and limited to the scope expressly defined in this document, the offer description or an individual agreement.
7. The Academic / Teaching Licence does not automatically grant the right to provide full PDF files to students, doctoral candidates, class participants, course participants or other persons, unless the Institute expressly grants such a right in the offer description or in an individual agreement.
8. The Academic / Teaching Licence does not replace a library, team, departmental, institutional, corporate or strategic licence if the manner of using the publication corresponds to the scope of those licences.

2. Definitions

For the purposes of this document, the following terms shall have the meanings set out below:

1. **Institute** – the Sir Roger Penrose Institute for Interdisciplinary Sciences.
2. **Licensee** – a university, academic unit, scientific unit, institute, doctoral school, educational unit, organisation, course instructor, lecturer, researcher or other entity that has purchased a publication or obtained access to a publication under the Academic / Teaching Licence.
3. **Instructor** – a natural person conducting classes, a lecture, seminar, course, workshop, tutorial, laboratory, project group, doctoral school or another form of teaching or academic activity.
4. **Class participant** – a student, doctoral candidate, learner, course participant, seminar participant, member of a student research circle or another person participating in the teaching, academic or educational activity of the Licensee.
5. **Publication** – any volume, report, monograph, analysis, methodological note, digital file, printed edition, additional material or other work made available by the Institute, in particular within the Report K* series.
6. **Report K*** – a series of specialised analytical publications of the Institute devoted to systemic analysis of technology, civilisation, social, economic, political, scientific and strategic processes, and complex transformational phenomena.
7. **Academic / Teaching Licence** – a licence authorising the use of publications in academic, teaching, seminar, educational, scientific or popularisation activities within the scope defined by the Institute.
8. **Teaching material** – a presentation, outline, syllabus, reading list, lecture excerpt, exercise, seminar questions, supporting materials or other material prepared by the Instructor for the purposes of classes, a course, seminar or educational activity.
9. **Educational platform** – a system used to conduct classes or make educational materials available, in particular Moodle, Teams, Google Classroom, a university platform, educational intranet or another digital system.
10. **Teaching access** – access to a publication or its fragments to the extent necessary to conduct classes, a seminar, course or educational activity, in accordance with this licence.
11. **Digital file** – a publication made available in electronic form, in particular as a PDF file.
12. **Printed edition** – a physical copy of a publication made available in printed form.
13. **Redistribution** – any transfer, sending, sharing, publication, copying, placement, sale, resale, exchange or dissemination of a publication or a substantial part thereof beyond the scope of the Academic / Teaching Licence.
14. **Material substituting the publication** – material which, through the scope of its summary, discussion, reconstruction of structure, presentation of data, models, tables, forecasts, conclusions or argumentation, enables the recipient to obtain, to a substantial

extent, the content, informational value or analytical value of the publication without purchasing it.

15. **Third party** – any person who is not an Instructor, Class participant or another person authorised to use the publication within the scope defined by the Academic / Teaching Licence.

3. Scope of the Academic / Teaching Licence

1. The Academic / Teaching Licence authorises the Licensee to use the publication in academic, teaching, scientific, seminar, educational or popularisation activities, in accordance with this document.
2. Under the Academic / Teaching Licence, the publication may be used in particular:
 - a) by the Instructor conducting classes,
 - b) as part of a lecture,
 - c) as part of a seminar,
 - d) as part of a tutorial,
 - e) as part of an academic course,
 - f) as part of a doctoral school,
 - g) as part of a student research circle,
 - h) as part of specialist classes,
 - i) as part of popularisation or educational activity,
 - j) for preparing a syllabus, reading list, bibliography or supporting material.
3. The Academic / Teaching Licence authorises the discussion of the content of the publication, references to its theses, concepts, models, methodology and conclusions, and the quotation of short excerpts in accordance with the rules set out in this document and applicable law.
4. The Academic / Teaching Licence does not automatically include the right to make the full publication available to Class participants.
5. The Academic / Teaching Licence does not automatically include the right to place a digital file of the publication on an educational platform, university system, intranet, repository, course folder or shared resource.
6. The Academic / Teaching Licence does not automatically include the right to print multiple copies of the publication for Class participants.
7. If the publication is to be made available in full to multiple Class participants, it is necessary to obtain an appropriate extended licence, library licence, digital licence, multi-access academic licence or another licence indicated by the Institute.

4. Permitted teaching use

1. Under the Academic / Teaching Licence, it is permitted to use the publication as a source of knowledge, analysis, context, inspiration, bibliographic material or point of reference in the teaching process.
2. Permitted use includes in particular:
 - a) listing the publication in a syllabus,
 - b) listing the publication in a course bibliography,
 - c) recommending the publication as reading material,
 - d) discussing the publication during classes,
 - e) quoting short excerpts from the publication in a presentation or teaching material,
 - f) using the concepts, models or theses of the publication as a starting point for discussion,
 - g) preparing seminar questions based on the publication,
 - h) preparing analytical assignments inspired by the publication,
 - i) referring to the publication in a lecture, seminar, course or educational material,
 - j) using the bibliographic data of the publication in reading lists.
3. The Instructor may present short quotations, selected theses, definitions, concepts or excerpts from the publication to Class participants if their use is justified by the teaching purpose and does not substitute the need to consult the source publication.
4. The Instructor may encourage Class participants to purchase the publication independently, use a library copy or obtain another lawful form of access.
5. The Instructor may not provide Class participants with the full PDF file, a scan of the publication, a digital copy or full chapters, unless separate consent of the Institute or a separate licence expressly permits this.
6. Teaching material prepared on the basis of the publication should have an independent character and must not substitute the Institute's publication.

5. Educational platforms and university systems

1. Placing the publication or a substantial part thereof on an educational platform requires an express authorisation arising from the offer description, an individual agreement or separate consent of the Institute.
2. The Academic / Teaching Licence does not automatically include the right to place a PDF file of the publication on platforms such as Moodle, Teams, Google Classroom, a university platform, intranet, course repository, class folder or document management system.

3. Without separate consent of the Institute, the Instructor may place on an educational platform:
 - a) the bibliographic data of the publication,
 - b) a link to the publication page or the Institute's store,
 - c) brief information about the publication,
 - d) short quotations to the extent justified by the teaching purpose,
 - e) the Instructor's own questions, assignments or comments referring to the publication.
4. Placing longer excerpts from the publication, full tables, full diagrams, full models, full recommendations, full chapters or the PDF file on an educational platform requires prior consent of the Institute.
5. If the Licensee wishes to provide Class participants with access to the full publication through an educational platform, the Licensee should obtain an appropriate multi-access licence, digital licence, library licence, extended academic licence or another licence indicated by the Institute.
6. The Licensee should secure the educational platform against access by unauthorised persons if any fragments of the publication are made available there under this licence or separate consent of the Institute.

6. Quotation and use of excerpts

1. The Academic / Teaching Licence does not limit the right to quote the publication within the scope permitted by applicable law.
2. Quotation of excerpts from the publication should be carried out with respect for copyright, academic integrity, the integrity of the author's statement and the principles of proper source attribution.
3. When quoting the publication, at least the following should be indicated:
 - a) the author's full name,
 - b) the title of the publication,
 - c) the name of the Report K* series, if the publication belongs to that series,
 - d) the name of the Institute,
 - e) the year of publication,
 - f) the page number or other information allowing the quoted excerpt to be identified, if available.
4. It is permitted to quote short excerpts from the publication for the purposes of analysis, criticism, polemic, explanation, teaching, review, expert commentary or one's own argumentation, provided that the quotation is justified by the purpose of use.

5. It is not permitted to quote, summarise or discuss the publication to an extent that substitutes the need to consult the source publication.
6. It is not permitted to publish substantial parts of the report, in particular full chapters, full tables, full matrices, full models, full forecasts, full diagrams, full recommendations or complete analytical structures, without prior consent of the Institute.
7. The Licensee, Instructor or Class participant may not present the methodology, models, thresholds, concepts, classifications, analytical structures or conclusions developed by the Institute as their own.
8. If the Licensee wishes to use a more extensive excerpt of the publication, a full table, chart, diagram, model, matrix, report structure or another substantial part of the publication, the Licensee should obtain prior consent of the Institute.

7. Teaching materials

1. The Instructor may prepare teaching materials inspired by the publication or referring to the publication as a source.
2. Teaching material should have an independent educational, analytical or authorial character.
3. Teaching material may not be a simple summary, reconstruction, abridgement, compilation or rewriting of the Institute's publication.
4. Teaching material may not substitute the purchase of the publication by Class participants.
5. Teaching material may not disclose, to a substantial extent, the content, structure, models, tables, forecasts, recommendations or argumentation of the Institute's publication.
6. If teaching material is substantially based on the Institute's publication, the publication should be clearly indicated as the source.
7. Teaching material may contain short quotations and discussions of excerpts from the publication, provided that their use is justified by the teaching purpose and complies with the law.
8. Teaching material may not subsequently be used as a paid course, training, educational product or commercial expert material based substantially on the Institute's publication without separate consent of the Institute.

8. Prohibitions and restrictions

1. Under the Academic / Teaching Licence, the following in particular is prohibited:
 - a) providing Class participants with the full PDF file without the consent of the Institute,
 - b) sending the publication by e-mail to students, doctoral candidates or course participants,

- c) placing the publication on an educational platform without the consent of the Institute,
 - d) placing the publication in a university system, intranet or repository without the consent of the Institute,
 - e) enabling Class participants to download the digital file,
 - f) scanning the printed edition in order to create a digital copy for Class participants,
 - g) creating multiple printed copies of the publication for Class participants,
 - h) making the publication available to unauthorised persons,
 - i) creating teaching materials that substitute the publication,
 - j) publishing full tables, diagrams, models, matrices, forecasts or recommendations without the consent of the Institute,
 - k) removing markings from the digital copy,
 - l) circumventing technical safeguards,
 - m) using the publication to train artificial intelligence models, automated content-processing systems or commercial databases without separate consent of the Institute,
 - n) using the publication in a manner that infringes the good name of the Institute, the author or the integrity of the publication.
2. It is prohibited to use the Academic / Teaching Licence to circumvent the requirement to obtain a library, team, departmental, corporate or strategic licence.
 3. It is prohibited to make the publication available as a course resource for an unlimited or unspecified number of participants.
 4. It is prohibited to include the full publication in a paid course, training programme, e-learning platform or educational product without separate consent of the Institute.
 5. In case of doubt as to whether a planned manner of use falls within the scope of the Academic / Teaching Licence, the Licensee should contact the Institute before commencing such use.

9. Digital publications and copy markings

1. Digital publications may be individually marked, including with the Licensee's data, the Instructor's data, order number, licence type, purchase date, access scope, teaching-use terms or other markings enabling the copy to be identified.
2. Digital copy markings may be visible or technical in nature.
3. Markings may serve in particular:
 - a) copyright protection,
 - b) prevention of unauthorised distribution,

- c) identification of the source of a licence breach,
 - d) verification of the scope of the licence granted,
 - e) protection of the Institute's legal interests.
4. Removing, modifying, obscuring, circumventing or hindering the reading of digital copy markings is prohibited.
 5. The Licensee may not remove metadata, watermarks, licence markings, copy numbers or other safeguards of the publication.
 6. In the future, the Institute may make digital publications available through its own digital reading room, access system, user accounts or another technical solution.
 7. A change in the technical method of making the publication available does not extend the scope of the Academic / Teaching Licence.

10. Printed editions

1. A printed edition covered by the Academic / Teaching Licence may be used by the Instructor or the Licensee as a teaching, academic, seminar or educational source.
2. Purchasing a printed edition does not grant the right to scan the publication, digitise the publication, create electronic copies or disseminate the content of the publication.
3. The Instructor may use the printed edition during classes, in particular discuss it, show the cover, indicate excerpts, quote short passages and recommend the publication as a source.
4. The Instructor may not make multiple printed copies of the publication for Class participants without separate consent of the Institute.
5. A printed edition purchased under the Academic / Teaching Licence is not automatically a library, corporate or strategic copy, unless the Institute expressly decides otherwise.
6. Placing a printed copy in a library, reading room, university archive or another place of shared use may require an appropriate Library Licence.

11. Academic / Teaching Subscription

1. The Academic / Teaching Subscription, if provided for in the Institute's offer, is a form of the Academic / Teaching Licence covering access to selected publications of the Report K* series during a specified subscription period.
2. The Academic / Teaching Subscription may include in particular:
 - a) regular volumes of the Report K* series,
 - b) special volumes, if the offer description so provides,
 - c) the possibility of using publications in syllabi and reading lists,
 - d) the possibility of discussing publications during classes,

- e) digital access in the Institute's reading room or another controlled system, if separately agreed,
 - f) preferential terms for purchasing additional publications,
 - g) other elements indicated in the offer description.
3. The Academic / Teaching Subscription does not automatically include the right to provide full PDF files to Class participants.
 4. The Academic / Teaching Subscription does not automatically include the right to place publications on educational platforms, unless the description of a specific offer provides otherwise.
 5. The Academic / Teaching Subscription does not automatically include special volumes, extended monographs, dedicated reports, analyses prepared on request or other publications not indicated in the package description, unless the description of a specific offer provides otherwise.
 6. A change in the price of individual volumes published after the commencement of the subscription does not affect the scope of publications covered by a subscription already paid for, unless the offer description provides otherwise.
 7. The Institute may change the prices, terms, scope or variants of future Academic / Teaching subscriptions.

12. Special volumes

1. Special volumes of the Report K* series may be sold separately or made available under selected subscription packages, if the description of a given package so provides.
2. The Academic / Teaching Licence for a special volume covers use within the academic or teaching scope specified in the offer description or an individual decision of the Institute.
3. Purchasing a special volume under the Academic / Teaching Licence does not grant the right to provide the full volume to Class participants, digitise it, digitally redistribute it, make the PDF file available or create electronic copies, unless the Institute expressly decides otherwise.
4. If the Licensee purchases a special volume on preferential terms as a subscriber, the scope of the licence remains the same as under the Academic / Teaching Licence, unless the Institute expressly decides otherwise.
5. Special volumes may have a separate price, separate availability scope, separate sales terms or separate licence restrictions if this follows from the nature of the publication.

13. Relationship to other licences

1. The Academic / Teaching Licence is intended for academic, teaching, seminar or educational use of publications.

2. If the publication is to be made available in a library, reading room, library catalogue or library resource, the Library Licence may be appropriate.
3. If the publication is to be used by a team, department, editorial office, law firm, strategy department, research team or project group, the Team / Departmental Licence may be appropriate.
4. If the publication is to be used in a large organisation, company, fund, public administration, international organisation or strategic activity, the Corporate / Strategic Licence may be appropriate.
5. If the publication is to be made available in full to entire groups of students, doctoral candidates or course participants, it may be necessary to obtain a multi-access licence or separate consent of the Institute.
6. If the Licensee is unsure which licence is appropriate for the planned manner of use, the Licensee should contact the Institute before purchasing or before commencing use beyond the scope of the Academic / Teaching Licence.

14. Breach of licence

1. A breach of the Academic / Teaching Licence is any use of the publication beyond the scope defined in this document, the offer description or an individual agreement.
2. A breach of the licence includes in particular:
 - a) providing the full PDF file to Class participants without the consent of the Institute,
 - b) placing the publication on an educational platform without the consent of the Institute,
 - c) making the publication available in a university system without the consent of the Institute,
 - d) creating a digital copy of the printed edition without the consent of the Institute,
 - e) mass-copying the publication for Class participants,
 - f) making the publication available to unauthorised persons,
 - g) making the publication available beyond the scope of classes or educational activity covered by the licence,
 - h) making the publication available on the Internet,
 - i) removing markings from the digital copy,
 - j) circumventing technical safeguards,
 - k) using the publication in a manner appropriate for an extended licence without obtaining such a licence,
 - l) disseminating substantial parts of the publication,

- m) presenting the methodology, models, structures or conclusions of the Institute as one's own,
 - n) using the publication to train artificial intelligence models or create databases without the consent of the Institute,
 - o) creating material that substitutes the publication.
3. In the event of a breach of the Academic / Teaching Licence, the Institute may in particular:
 - a) revoke access to digital publications,
 - b) block access to the digital reading room, if such a technical solution is used,
 - c) refuse to sell further publications,
 - d) refuse participation in support programmes,
 - e) refuse to grant further licences,
 - f) demand the purchase of the appropriate extended licence,
 - g) pursue copyright protection,
 - h) seek damages or other claims provided for by law.
 4. Revocation of access due to a breach of the licence does not create an obligation to refund the price of the publication, the subscription price or any other fees paid by the Licensee.
 5. The Institute may call upon the Licensee to cease the breach, provide explanations, indicate the source of the breach, confirm the removal of unauthorised copies of the publication or regularise the scope of the licence.
 6. Failure by the Licensee to respond to the Institute's notice may be regarded as a circumstance aggravating the breach of the licence.

15. Liability of the Licensee

1. The Licensee is responsible for the manner of using the publication covered by the Academic / Teaching Licence.
2. The Licensee should secure digital files, printed copies and teaching access against unauthorised use.
3. The Licensee is responsible for making the publication available to third parties if this occurred as a result of an act, omission, negligence or improper safeguarding of the publication by the Licensee, its employees, associates, representatives, users or persons acting on its behalf.
4. The Licensee should take reasonable organisational measures to prevent unauthorised distribution of the publication.
5. The Licensee should promptly inform the Institute of the loss of a file, unauthorised access, suspected licence breach or disclosure of the publication to third parties.

6. The Licensee is not liable for breaches resulting solely from causes attributable to the Institute or from actions of third parties over whom the Licensee had no control, provided that the Licensee exercised due care in safeguarding the publication.

16. Amendment of licence terms

1. The Institute may amend these licence terms, in particular in the event of changes in law, changes in the method of distribution of publications, launch of a digital reading room, changes in technical safeguards, changes in the licence structure or the need to clarify the rules for using publications.
2. The amended licence terms apply to publications purchased after the date of entry into force of the new terms, unless applicable law or the offer description provides otherwise.
3. In the case of subscriptions active on the date of amendment of the terms, the new terms may apply to volumes made available after the date of amendment, provided that this does not infringe the Licensee's acquired rights to publications already made available.
4. The current version of the licence terms is published on the Institute's website or made available together with the publication.

17. Final provisions

1. In matters not regulated by this document, applicable law and the relevant regulations of the Institute shall apply.
2. If any provision of these terms proves invalid, ineffective or impossible to perform, this shall not affect the validity of the remaining provisions.
3. In the event of any discrepancy between this document and an individual agreement concluded with the Licensee, the provisions of the individual agreement shall prevail.
4. In the event of any discrepancy between this document and the description of a specific offer, the offer description shall prevail to the extent that it grants the Licensee broader rights or defines special access conditions.
5. The Academic / Teaching Licence applies from the moment of purchasing the publication, obtaining access to the publication or commencing a subscription in the academic or teaching variant, unless the offer description provides otherwise.
6. These licence terms enter into force on the date of their publication on the Institute's website.
