to the Report K* series and other publications of the Institute
under the Library Licence.

of the Institute No. 13/05/2026 of 9 May 2026.

1. General provisions

1. This document defines the terms of the Library Licence for the use of publications of the Report K* series and other publications made available by the Sir Roger Penrose Institute for Interdisciplinary Sciences.
2. The Library Licence is intended for libraries, reading rooms, academic libraries, scientific libraries, institute libraries, public libraries, archives, documentation centres, educational units and other entities maintaining an organised library or reading resource.
3. The Library Licence authorises making publications available to users of a library or reading room within the scope defined in this document, the offer description, the order, the regulations of the relevant library and any individual decision of the Institute.
4. The Library Licence may apply in particular to:
 - a) a single regular volume of the Report K* series,
 - b) a single special volume of the Report K* series,
 - c) an analytical monograph published by the Institute,
 - d) a methodological report,
 - e) a printed edition,
 - f) a digital publication made available on terms agreed with the Institute,
 - g) a library access package,
 - h) a library subscription, if provided for in the Institute's offer.
5. The Library Licence does not transfer to the Licensee any economic copyrights to the publication or any intellectual property rights to the methodology, analytical structure, models, concepts, forecasts, charts, tables, diagrams, studies or other elements of the publication protected by law.
6. The Library Licence is non-exclusive, non-transferable, non-sublicensable and limited to the scope expressly defined in this document, the offer description or an individual agreement.
7. The Library Licence does not include the right to commercially redistribute publications, sell copies, provide digital files to users, publish reports on the Internet or make them available beyond the scope of the relevant library resource.
8. The Library Licence does not replace an academic, teaching, team, departmental, corporate or strategic licence if the manner of using the publication corresponds to the scope of those licences.

2. Definitions

For the purposes of this document, the following terms shall have the meanings set out below:

1. **Institute** – the Sir Roger Penrose Institute for Interdisciplinary Sciences.

2. **Licensee** – a library, reading room, archive, university, institute, scientific unit, educational unit, organisation or other entity that has purchased a publication or obtained access to a publication under the Library Licence.
3. **Library** – an organised collection of publications maintained by the Licensee and made available to users in accordance with the regulations of the library, reading room, archive or relevant organisational unit.
4. **Library user** – a person authorised to use the Licensee’s library resource in accordance with the regulations of that resource.
5. **Publication** – any volume, report, monograph, analysis, methodological note, digital file, printed edition, additional material or other work made available by the Institute, in particular within the Report K* series.
6. **Report K*** – a series of specialised analytical publications of the Institute devoted to systemic analysis of technology, civilisation, social, economic, political, scientific and strategic processes, and complex transformational phenomena.
7. **Library Licence** – a licence authorising the Licensee to make publications available within a library, reading room or archival resource, in accordance with the scope defined by the Institute.
8. **Library copy** – a copy of a publication intended to be made available to library users within the scope appropriate for the Library Licence.
9. **Reading-room access** – use of the publication on site, in a reading room, library, archive or another controlled place of access.
10. **Digital library access** – access to a digital publication granted to a library on the basis of separately agreed technical, organisational and licensing terms.
11. **Digital file** – a publication made available in electronic form, in particular as a PDF file.
12. **Printed edition** – a physical copy of a publication made available in printed form.
13. **Redistribution** – any transfer, sending, sharing, publication, copying, placement, sale, resale, exchange or dissemination of a publication or a substantial part thereof beyond the scope of the Library Licence.
14. **Remote access** – access to a publication outside the physical premises of the library, reading room or other place of access, in particular via the Internet, a user account, library system, digital platform or electronic resource.
15. **Third party** – any person who is not a library user authorised to use the publication in accordance with the scope of the Library Licence.

3. Scope of the Library Licence

1. The Library Licence authorises the Licensee to include the publication in a library, reading-room or archival resource and to make it available to users within the scope defined in this document.

2. The basic scope of the Library Licence is the controlled provision of a printed copy, in accordance with the regulations of the library or reading room.
3. The Library Licence may include:
 - a) making a printed copy available on site,
 - b) lending a printed copy, if permitted by the library regulations and the Institute's offer description,
 - c) including the publication in the library catalogue,
 - d) storing the publication in a library or archival resource,
 - e) making a digital publication available in a controlled access system, if this has been separately agreed with the Institute,
 - f) using the publication as a bibliographic, scientific, educational or analytical source.
4. The Library Licence does not automatically include the right to make digital files available to library users.
5. The Library Licence does not automatically include the right to provide remote digital access, unless the Institute expressly grants such a right in the offer description, an individual agreement or separate technical terms.
6. The Library Licence does not include the right to digitise a printed edition, scan the publication or create digital library copies, unless applicable law or separate consent of the Institute expressly permits this.
7. The Library Licence does not include the right to make the publication available as an open digital resource, downloadable file, material in an open repository or a document available without user control.

4. Printed copies

1. A printed copy covered by the Library Licence may be included in the Licensee's library resource.
2. The Licensee may make the printed copy available to library users in accordance with the library regulations, the scope of the licence and the nature of the publication.
3. The Licensee may mark the printed copy with a library shelf mark, stamp, catalogue code or another marking appropriate for internal library procedures.
4. A library marking may not infringe the integrity of the publication, remove the Institute's markings, remove information about the author, remove information about the licence or make identification of the publication difficult.
5. The Licensee may not scan the printed copy in order to create a digital copy available to library users, unless separate legal provisions or written consent of the Institute expressly permit this.

6. The Licensee may not make multiple printed copies of the publication on the basis of a single library copy.
7. The Licensee may not make photocopies of substantial parts of the publication available to library users in a manner that substitutes the purchase of the publication or infringes copyright.
8. In the case of publications of particular value, limited availability or particular analytical significance, the Institute may indicate that the printed copy should be made available only on site.

5. Digital publications and digital library access

1. Digital publications under the Library Licence may be made available only on terms expressly defined by the Institute.
2. The purchase of a digital file by a library does not automatically grant the right to:
 - a) provide the file to library users,
 - b) enable downloading of the file,
 - c) send the file by e-mail,
 - d) place the file in a digital catalogue,
 - e) place the file in a repository,
 - f) place the file in an intranet,
 - g) place the file in a library system accessible to users,
 - h) provide remote access to the file,
 - i) print multiple copies from the digital file for library users.
3. Digital library access requires separate agreement with the Institute, in particular with respect to:
 - a) the number of users,
 - b) the method of user authentication,
 - c) the place of access,
 - d) the possibility or prohibition of downloading the file,
 - e) the possibility or prohibition of printing,
 - f) the duration of access,
 - g) technical safeguards,
 - h) the scope of the Licensee's liability.

4. The Institute may make the granting of digital library access conditional upon the use of the Institute's digital reading room, individual user accounts, terminal access or another controlled technical solution.
5. The Licensee may not independently create a digital reading room, repository, PDF database or remote access system for the Institute's publications without the prior consent of the Institute.
6. In the event of a breach of the rules of digital access, the Institute may revoke digital access without any obligation to refund the fee, if the breach results from an act, omission or improper safeguarding on the part of the Licensee.

6. Permitted use

1. Under the Library Licence, it is permitted to use the publication within the scope appropriate for the Licensee's library, reading-room, scientific, educational or archival activities.
2. Permitted use includes in particular:
 - a) including the publication in the library catalogue,
 - b) storing the publication in a library resource,
 - c) making the printed copy available to library users,
 - d) making the printed copy available in a reading room,
 - e) keeping records of the use of the publication in accordance with library procedures,
 - f) recommending the publication as a scientific, educational or analytical source,
 - g) quoting short excerpts from the publication with source attribution,
 - h) using the bibliographic data of the publication in catalogues, bibliographies, syllabi, reading lists or library recommendations.
3. The Licensee may inform library users about the availability of the publication in the library resource.
4. The Licensee may include in the library catalogue the bibliographic description of the publication, cover, publisher's summary or other information made available by the Institute for informational purposes.
5. The Licensee may not publish in the catalogue, repository or library system such excerpts from the publication as would, to a substantial extent, substitute the need to consult the source publication.

7. Quotation and use of excerpts

1. The Library Licence does not limit the right to quote the publication within the scope permitted by applicable law.

2. Quotation of excerpts from the publication should be carried out with respect for copyright, academic integrity and the integrity of the author's statement.
3. When quoting the publication, at least the following should be indicated:
 - a) the author's full name,
 - b) the title of the publication,
 - c) the name of the Report K* series, if the publication belongs to that series,
 - d) the name of the Institute,
 - e) the year of publication,
 - f) the page number or other information allowing the quoted excerpt to be identified, if available.
4. Library users may quote the publication in accordance with applicable law; however, the Licensee should take reasonable organisational measures to ensure that use of the publication within the library does not lead to systemic copyright infringement.
5. It is not permitted to publish substantial parts of the report, in particular full chapters, full tables, full matrices, full models, full forecasts, full diagrams, full recommendations or complete analytical structures, without prior consent of the Institute.
6. The Licensee may not present the methodology, models, thresholds, concepts, classifications, analytical structures or conclusions developed by the Institute as its own.

8. Prohibitions and restrictions

1. Under the Library Licence, the following in particular is prohibited:
 - a) sending a PDF file to library users, unless this has been expressly permitted by the Institute,
 - b) enabling library users to download a digital file, unless this has been expressly permitted by the Institute,
 - c) placing the publication in open repositories,
 - d) placing the publication in institutional repositories without the consent of the Institute,
 - e) placing the publication in library systems as a downloadable file,
 - f) placing the publication in an intranet or digital system accessible beyond the scope of the licence,
 - g) scanning a printed edition in order to create a digital library copy without the consent of the Institute,
 - h) creating multiple printed copies of the publication,
 - i) creating multiple digital copies of the publication,

- j) selling copies of the publication,
 - k) making the publication available to unauthorised persons,
 - l) removing markings from the digital copy,
 - m) circumventing technical safeguards,
 - n) using the publication to train artificial intelligence models, automated content-processing systems or commercial databases without separate consent of the Institute,
 - o) creating summaries, studies, presentations or materials that substantially substitute the purchase of the publication,
 - p) using the publication in a manner that infringes the good name of the Institute, the author or the integrity of the publication.
2. The Licensee may not make the publication available in a manner leading to uncontrolled dissemination of the content.
 3. The Licensee may not make the publication available through interlibrary lending in digital form, unless the Institute expressly grants such a right.
 4. The Licensee may not make the publication available as teaching material for entire groups of students without an appropriate Academic / Teaching Licence.
 5. The Licensee may not use the Library Licence to circumvent the requirement to obtain an academic, institutional, team, corporate or strategic licence.
 6. In case of doubt as to whether a planned manner of use falls within the scope of the Library Licence, the Licensee should contact the Institute before commencing such use.

9. Digital copy markings

1. Digital publications may be individually marked, including with the Licensee's data, order number, licence type, purchase date, access scope, library access terms or other markings enabling the copy to be identified.
2. Digital copy markings may be visible or technical in nature.
3. Markings may serve in particular:
 - a) copyright protection,
 - b) prevention of unauthorised distribution,
 - c) identification of the source of a licence breach,
 - d) verification of the scope of the licence granted,
 - e) protection of the Institute's legal interests.
4. Removing, modifying, obscuring, circumventing or hindering the reading of digital copy markings is prohibited.

5. The Licensee may not remove metadata, watermarks, licence markings, copy numbers or other safeguards of the publication.
6. A change in the technical method of making the publication available does not extend the scope of the Library Licence.

10. Library subscription

1. A library subscription, if provided for in the Institute's offer, is a form of the Library Licence covering access to selected publications of the Report K* series during a specified subscription period.
2. A library subscription may include in particular:
 - a) printed copies of regular volumes,
 - b) printed copies of special volumes, if the offer description so provides,
 - c) digital access in the Institute's reading room or another controlled system, if separately agreed,
 - d) preferential terms for purchasing additional publications,
 - e) other elements indicated in the offer description.
3. A library subscription does not automatically include the right to digitally make publications available to library users.
4. A library subscription does not automatically include special volumes, extended monographs, dedicated reports, analyses prepared on request or other publications not indicated in the package description, unless the description of a specific offer provides otherwise.
5. A change in the price of individual volumes published after the commencement of the subscription does not affect the scope of publications covered by a subscription already paid for, unless the offer description provides otherwise.
6. The Institute may change the prices, terms, scope or variants of future library subscriptions.

11. Special volumes

1. Special volumes of the Report K* series may be sold separately or made available under selected subscription packages, if the description of a given package so provides.
2. The Library Licence for a special volume covers use within the library scope specified in the offer description or an individual decision of the Institute.
3. Purchasing a special volume under the Library Licence does not grant the right to digitise it, digitally redistribute it, make the PDF file available or create electronic copies, unless the Institute expressly decides otherwise.

4. If the Licensee purchases a special volume on preferential terms as a subscriber, the scope of the licence remains the same as under the Library Licence, unless the Institute expressly decides otherwise.
5. Special volumes may have a separate price, separate availability scope, separate sales terms or separate licence restrictions if this follows from the nature of the publication.

12. Relationship to other licences

1. The Library Licence is intended for library, reading-room or archival access to publications.
2. If the publication is to be used by a team, department, editorial office, law firm, strategy department, research team, project group or several persons within one institution, the Team / Departmental Licence may be appropriate.
3. If the publication is to be used in teaching, classes, seminars, academic courses or educational systems, the Academic / Teaching Licence may be appropriate.
4. If the publication is to be used in a large organisation, company, fund, public administration, international organisation or strategic activity, the Corporate / Strategic Licence may be appropriate.
5. If the Licensee is unsure which licence is appropriate for the planned manner of use, the Licensee should contact the Institute before purchasing or before commencing use beyond the scope of the Library Licence.

13. Breach of licence

1. A breach of the Library Licence is any use of the publication beyond the scope defined in this document, the offer description or an individual agreement.
2. A breach of the licence includes in particular:
 - a) making a digital file available to library users without the consent of the Institute,
 - b) enabling downloading of a digital file,
 - c) placing the publication in an open or institutional repository without the consent of the Institute,
 - d) creating a digital copy of the printed edition without the consent of the Institute,
 - e) mass-copying the publication,
 - f) making the publication available to unauthorised persons,
 - g) making the publication available beyond the scope of the library resource,
 - h) making the publication available on the Internet,
 - i) removing markings from the digital copy,
 - j) circumventing technical safeguards,

- k) using the publication in a manner appropriate for an extended licence without obtaining such a licence,
 - l) disseminating substantial parts of the publication,
 - m) presenting the methodology, models, structures or conclusions of the Institute as one's own,
 - n) using the publication to train artificial intelligence models or create databases without the consent of the Institute,
 - o) creating material that substitutes the publication.
3. In the event of a breach of the Library Licence, the Institute may in particular:
 - a) revoke access to digital publications,
 - b) block access to the digital reading room, if such a technical solution is used,
 - c) refuse to sell further publications,
 - d) refuse participation in support programmes,
 - e) refuse to grant further licences,
 - f) demand the purchase of the appropriate extended licence,
 - g) pursue copyright protection,
 - h) seek damages or other claims provided for by law.
 4. Revocation of access due to a breach of the licence does not create an obligation to refund the price of the publication, the subscription price or any other fees paid by the Licensee.
 5. The Institute may call upon the Licensee to cease the breach, provide explanations, indicate the source of the breach, confirm the removal of unauthorised copies of the publication or regularise the scope of the licence.
 6. Failure by the Licensee to respond to the Institute's notice may be regarded as a circumstance aggravating the breach of the licence.

14. Liability of the Licensee

1. The Licensee is responsible for the manner of using the publication covered by the Library Licence.
2. The Licensee should secure digital files, printed copies and library access against unauthorised use.
3. The Licensee is responsible for making the publication available to third parties if this occurred as a result of an act, omission, negligence or improper safeguarding of the publication by the Licensee, its employees, associates, representatives, users or persons acting on its behalf.

4. The Licensee should take reasonable organisational measures to prevent unauthorised distribution of the publication.
5. The Licensee should promptly inform the Institute of the loss of a file, unauthorised access, suspected licence breach or disclosure of the publication to third parties.
6. The Licensee is not liable for breaches resulting solely from causes attributable to the Institute or from actions of third parties over whom the Licensee had no control, provided that the Licensee exercised due care in safeguarding the publication.

15. Amendment of licence terms

1. The Institute may amend these licence terms, in particular in the event of changes in law, changes in the method of distribution of publications, launch of a digital reading room, changes in technical safeguards, changes in the licence structure or the need to clarify the rules for using publications.
2. The amended licence terms apply to publications purchased after the date of entry into force of the new terms, unless applicable law or the offer description provides otherwise.
3. In the case of subscriptions active on the date of amendment of the terms, the new terms may apply to volumes made available after the date of amendment, provided that this does not infringe the Licensee's acquired rights to publications already made available.
4. The current version of the licence terms is published on the Institute's website or made available together with the publication.

16. Final provisions

1. In matters not regulated by this document, applicable law and the relevant regulations of the Institute shall apply.
2. If any provision of these terms proves invalid, ineffective or impossible to perform, this shall not affect the validity of the remaining provisions.
3. In the event of any discrepancy between this document and an individual agreement concluded with the Licensee, the provisions of the individual agreement shall prevail.
4. In the event of any discrepancy between this document and the description of a specific offer, the offer description shall prevail to the extent that it grants the Licensee broader rights or defines special access conditions.
5. The Library Licence applies from the moment of purchasing the publication, obtaining access to the publication or commencing a subscription in the library variant, unless the offer description provides otherwise.
6. These licence terms enter into force on the date of their publication on the Institute's website.
