under the Team / Departmental Licence.

were approved by resolution of the Management Board
of the Institute No. 12/05/2026 of 9 May 2026.

1. General provisions

1. This document defines the terms of the Team / Departmental Licence for the use of publications of the Report K* series and other publications made available by the Sir Roger Penrose Institute for Interdisciplinary Sciences.
2. The Team / Departmental Licence is intended for teams, divisions, departments, editorial offices, law firms, analytical units, research teams, expert offices, advisory units, think-tanks, organisations, companies and other entities in which a publication is used by more than one person.
3. The Team / Departmental Licence authorises the use of a publication by a specified number of users, in accordance with the selected licence variant, the offer description, the order or an individual decision of the Institute.
4. The Team / Departmental Licence may include in particular the following variants:
 - a) up to 3 users,
 - b) up to 5 users,
 - c) up to 10 users,
 - d) more than 10 users – on the basis of individual pricing and separate terms.
5. The Team / Departmental Licence may apply in particular to:
 - a) a single regular volume of the Report K* series,
 - b) a single special volume of the Report K* series,
 - c) an analytical monograph published by the Institute,
 - d) a methodological report,
 - e) a digital publication in PDF format or another electronic format,
 - f) a printed publication,
 - g) a team or departmental access package,
 - h) a Report K* – Team / Departmental subscription.
6. Purchasing a publication, obtaining access to a publication or having a publication covered by a subscription in the Team / Departmental variant constitutes acceptance of these licence terms, unless the parties expressly agree otherwise in a separate agreement or individual offer of the Institute.
7. The Team / Departmental Licence does not transfer to the Licensee any economic copyrights to the publication or any intellectual property rights to the methodology, analytical structure, models, concepts, forecasts, charts, tables, diagrams, studies or other elements of the publication protected by law.
8. The Team / Departmental Licence is non-exclusive, non-transferable, non-sublicensable and limited to the number of users and the scope expressly defined in this document, the offer description or an individual agreement.

9. The Team / Departmental Licence does not include the right to make a publication available to the entire institution, all employees, all branches, all students, the entire organisation, the entire network of entities or an unspecified number of recipients.
10. The Team / Departmental Licence does not replace a library, academic, corporate or strategic licence if the manner of using the publication corresponds to the scope of those licences.

2. Definitions

For the purposes of this document, the following terms shall have the meanings set out below:

1. **Institute** – the Sir Roger Penrose Institute for Interdisciplinary Sciences.
2. **Licensee** – an institution, organisation, company, editorial office, law firm, team, division, department, research unit, analytical centre, think-tank, foundation, association or other entity that has purchased a publication or obtained access to a publication under the Team / Departmental Licence.
3. **Publication** – any volume, report, monograph, analysis, methodological note, digital file, printed edition, additional material or other work made available by the Institute, in particular within the Report K* series.
4. **Report K*** – a series of specialised analytical publications of the Institute devoted to systemic analysis of technology, civilisation, social, economic, political, scientific and strategic processes, and complex transformational phenomena.
5. **Team / Departmental Licence** – a licence authorising a specified number of users within one team, division, department, editorial office, law firm, analytical unit, organisational unit or other designated organisational scope to use a publication.
6. **Authorised user** – a natural person indicated by the Licensee or falling within the scope indicated by the Licensee and accepted by the Institute as a person authorised to use a publication under the Team / Departmental Licence.
7. **Authorised team** – a specified group of users within the Licensee, covered by the Team / Departmental Licence.
8. **User limit** – the maximum number of natural persons authorised to use a publication under a given licence variant.
9. **Team / Departmental Subscription** – a team or departmental access package to regular volumes of the Report K* series during the selected subscription period, intended for a specified number of users.
10. **Regular volume** – a recurring volume of the Report K* series, covering a specific area of systemic analysis and published in accordance with the Institute's publishing rhythm.
11. **Special volume** – a publication of the Report K* series devoted to a particular problem, event, systemic threshold, strategic situation or topic requiring separate analysis.
12. **Digital file** – a publication made available in electronic form, in particular as a PDF file.

13. **Printed edition** – a physical copy of a publication made available in printed form.
14. **Redistribution** – any transfer, sending, sharing, publication, copying, placement, sale, resale, exchange or dissemination of a publication or a substantial part thereof to a third party, team, institution, organisation or unauthorised recipient.
15. **External access** – any access to a publication by persons outside the scope of the Team / Departmental Licence, in particular by clients, contractors, students, training participants, subcontractors, newsletter recipients, users of online platforms or other third parties.
16. **Third party** – any person who is not an Authorised user and does not fall within the user limit covered by the Team / Departmental Licence.

3. Scope of the Team / Departmental Licence

1. The Team / Departmental Licence authorises the Licensee to use a publication by a specified number of users, in accordance with the selected licence variant.
2. Under the Team / Departmental Licence, the publication may be used by Authorised users within:
 - a) one team,
 - b) one division,
 - c) one department,
 - d) one editorial office,
 - e) one law firm,
 - f) one analytical unit,
 - g) one research team,
 - h) one expert office,
 - i) one project,
 - j) another limited organisational scope indicated at the time of purchase or accepted by the Institute.
3. The Team / Departmental Licence authorises the use of a publication as a source of knowledge, analysis, context, research inspiration, internal material or material supporting the work of the team covered by the licence.
4. The Team / Departmental Licence does not include the right to:
 - a) make the publication available to persons outside the user limit,
 - b) make the publication available to the entire institution,
 - c) make the publication available to all employees of the Licensee,
 - d) make the publication available to all members of the organisation,
 - e) make the publication available to all students,

- f) make the publication available to all clients or contractors,
 - g) place the publication in resources accessible to an unspecified number of persons,
 - h) use the publication by persons outside the indicated organisational scope,
 - i) use the publication as a library resource,
 - j) use the publication as teaching material made available to students,
 - k) use the publication as a corporate or strategic resource beyond the selected user limit.
5. If the publication is to be used by a greater number of persons than provided for in the selected licence variant, it is necessary to extend the licence or obtain another appropriate licence.

4. User limit and user list

1. The Licensee is obliged to comply with the user limit applicable to the selected variant of the Team / Departmental Licence.
2. The user limit means the maximum number of natural persons who may use the publication under a given licence.
3. The Licensee may be required to indicate a list of Authorised users, in particular in the case of digital publications, access through a digital reading room, user accounts or individual marking of copies.
4. If the Institute does not require an individual list of Authorised users, the Licensee should internally control that the number of persons actually using the publication does not exceed the licence limit.
5. The Licensee may change an Authorised user only if:
 - a) this results from a natural organisational change,
 - b) the previous Authorised user has ceased to perform the given function or has ceased to use the publication,
 - c) the publication will not be used simultaneously by the previous and the new Authorised user,
 - d) the change does not lead to a de facto exceeding of the user limit.
6. The Licensee may not use rotational access to the publication in order to circumvent the user limit.
7. Rotational transfer of the file, passwords, links, printouts or other forms of access to successive persons may be considered a breach of the licence.
8. If the Licensee needs to increase the number of users, the Licensee should purchase a higher licence variant or obtain individual consent of the Institute.

5. Permitted use

1. Under the Team / Departmental Licence, the publication may be used by Authorised users within the scope related to the Licensee's activity and the purpose of purchasing the licence.
2. Permitted use includes in particular:
 - a) reading the publication by Authorised users,
 - b) analysing the content of the publication,
 - c) discussing the publication within the team covered by the licence,
 - d) preparing internal notes for the team covered by the licence,
 - e) using the publication as a source of knowledge in analytical, expert, research, editorial, advisory, strategic or decision-making work,
 - f) quoting short excerpts from the publication with source attribution,
 - g) referring to the theses, concepts, models or conclusions of the publication with clear source attribution,
 - h) storing the publication in a secured digital resource accessible only to Authorised users,
 - i) keeping one backup copy of the digital file, provided that this copy is not made available to unauthorised persons.
3. The Licensee may use conclusions from the publication in internal work of the team covered by the licence, provided that this does not lead to the dissemination of substantial parts of the publication beyond the scope of the licence.
4. The Licensee may refer to the publication as a source in documents, analyses, notes, studies or its own materials, provided that the scope of quotation and discussion does not substitute the source publication.
5. The Licensee may not create internal studies, summaries, presentations or knowledge bases that, to a substantial extent, substitute the purchase of the publication by other persons, teams or organisational units.

6. Quotation and use of excerpts

1. The Team / Departmental Licence does not limit the right to quote the publication within the scope permitted by applicable law.
2. Quotation of excerpts from the publication should be carried out with respect for copyright, academic integrity and the integrity of the author's statement.
3. When quoting the publication, at least the following should be indicated:
 - a) the author's full name,

- b) the title of the publication,
 - c) the name of the Report K* series, if the publication belongs to that series,
 - d) the name of the Institute,
 - e) the year of publication,
 - f) the page number or other information allowing the quoted excerpt to be identified, if available.
4. It is permitted to quote short excerpts from the publication for the purposes of analysis, criticism, polemic, explanation, teaching, review, expert commentary or one's own argumentation, provided that the quotation is justified by the purpose of use.
 5. It is not permitted to quote, summarise or discuss the publication to an extent that substitutes the need to consult the source publication.
 6. It is not permitted to publish substantial parts of the report, in particular full chapters, full tables, full matrices, full models, full forecasts, full diagrams, full recommendations or complete analytical structures, without prior consent of the Institute.
 7. The Licensee may not present the methodology, models, thresholds, concepts, classifications, analytical structures or conclusions developed by the Institute as its own.
 8. If the Licensee wishes to use a more extensive excerpt of the publication, a full table, chart, diagram, model, matrix, report structure or another substantial part of the publication, the Licensee should obtain prior consent of the Institute.

7. Prohibitions and restrictions

1. Under the Team / Departmental Licence, the following in particular is prohibited:
 - a) sending a PDF file to unauthorised persons,
 - b) making the publication available to persons outside the user limit,
 - c) making the publication available to the entire institution,
 - d) making the publication available to all employees or members of the Licensee,
 - e) making the publication available to clients, contractors, students, training participants or external recipients,
 - f) copying the publication for further dissemination,
 - g) placing the publication in open repositories,
 - h) placing the publication in closed repositories accessible to persons outside the scope of the licence,
 - i) placing the publication in an intranet accessible to persons outside the scope of the licence,

- j) placing the publication on shared drives accessible to persons outside the scope of the licence,
 - k) placing the publication in knowledge management systems, educational platforms, document systems, knowledge bases or team resources accessible beyond the scope of the licence,
 - l) making the publication available via cloud storage if unauthorised persons may gain access to the file,
 - m) printing the digital file in multiple copies for the purpose of providing them to persons outside the scope of the licence,
 - n) reselling the digital publication,
 - o) transferring the digital file for payment or free of charge,
 - p) creating copies of the publication for persons or organisational units not covered by the licence,
 - q) removing markings from the digital copy,
 - r) circumventing technical safeguards,
 - s) using the publication to train artificial intelligence models, automated content-processing systems or commercial databases without separate consent of the Institute,
 - t) creating summaries, studies, presentations or materials that substantially substitute the purchase of the publication,
 - u) using the publication in a manner that infringes the good name of the Institute, the author or the integrity of the publication.
2. It is prohibited to make the publication available to persons outside the team, division, department, editorial office, law firm, project or other organisational scope covered by the licence.
 3. It is prohibited to use the Team / Departmental Licence to circumvent the requirement to obtain a library, academic, corporate or strategic licence.
 4. It is prohibited to purchase a publication in the up to 3, up to 5 or up to 10 users variant for the purpose of actual use of the publication by a greater number of persons.
 5. In case of doubt as to whether a planned manner of use falls within the scope of the Team / Departmental Licence, the Licensee should contact the Institute before commencing such use.

8. Digital files and copy markings

1. Digital publications may be individually marked, including with the Licensee's data, Authorised users' data, order number, licence type, purchase date, access scope, user limit or other markings enabling the copy to be identified.
2. Digital copy markings may be visible or technical in nature.

3. Markings may serve in particular:
 - a) copyright protection,
 - b) prevention of unauthorised distribution,
 - c) identification of the source of a licence breach,
 - d) verification of the scope of the licence granted,
 - e) protection of the Institute's legal interests.
4. Removing, modifying, obscuring, circumventing or hindering the reading of digital copy markings is prohibited.
5. The Licensee may not remove metadata, watermarks, licence markings, copy numbers or other safeguards of the publication.
6. In the future, the Institute may make digital publications available through its own digital reading room, access system, user accounts or another technical solution.
7. A change in the technical method of making the publication available does not extend the scope of the Team / Departmental Licence.

9. Printed editions

1. A printed edition covered by the Team / Departmental Licence is intended for use by Authorised users within the user limit and organisational scope indicated in the licence.
2. Purchasing a printed edition does not grant the right to scan the publication, digitise the publication, create electronic copies or disseminate the content of the publication.
3. The Licensee may use the printed edition in a manner consistent with the scope of the licence, in particular read it, mark excerpts, make notes and store the copy for the needs of the team covered by the licence.
4. A printed edition purchased under the Team / Departmental Licence is not a library, academic, corporate or strategic copy, unless the Institute expressly decides otherwise.
5. Placing the printed copy in a library, reading room, institutional archive, library resource or another place of shared use by an unspecified number of persons may require an appropriate library, academic or corporate licence.
6. The Licensee may resell the physical printed copy if permitted by applicable law; however, resale of the printed copy does not include the transfer of digital files, digital access, user accounts or additional materials made available electronically.

10. Team / Departmental Subscription

1. The Report K* – Team / Departmental Subscription is a form of the Team / Departmental Licence covering access to regular volumes of the Report K* series during the selected subscription period.

2. The Team / Departmental Subscription is intended for one Licensee and includes use by a specified number of Authorised users.
3. The Team / Departmental Subscription may be offered in particular in the following user variants:
 - a) up to 3 users,
 - b) up to 5 users,
 - c) up to 10 users,
 - d) more than 10 users – on the basis of individual pricing.
4. The Team / Departmental Subscription may be offered in particular in the following time variants:
 - a) tertial subscription – 4 months / 2 regular volumes,
 - b) half-year subscription – 6 months / 3 regular volumes,
 - c) annual subscription – 12 months / 6 regular volumes.
5. The Team / Departmental Subscription includes only the publications indicated in the description of a given subscription package.
6. The Team / Departmental Subscription does not automatically include special volumes, extended monographs, dedicated reports, analyses prepared on request or other publications not indicated in the package description, unless the description of a specific offer provides otherwise.
7. The subscriber may obtain the possibility to purchase special volumes or other publications on preferential terms if this is provided for in the current price list, the offer description or an individual decision of the Institute.
8. The Team / Departmental Subscription does not include the right to make publications available to all employees, the entire institution, all members of the organisation, all students, clients, contractors or persons outside the scope of the licence.
9. A change in the price of individual volumes published after the commencement of the subscription does not affect the scope of publications covered by a subscription already paid for, unless the offer description provides otherwise.
10. The Institute may change the prices, terms, scope or variants of future subscriptions.

11. Special volumes

1. Special volumes of the Report K* series may be sold separately or made available under selected subscription packages, if the description of a given package so provides.
2. The Team / Departmental Licence for a special volume covers use by a specified number of Authorised users, in accordance with the selected licence variant.

3. Purchasing a special volume under the Team / Departmental Licence does not grant the right to make the special volume available to all employees, the entire institution, students, clients, contractors or persons outside the scope of the licence.
4. If the Licensee purchases a special volume on preferential terms as a subscriber, the scope of the licence remains the same as under the Team / Departmental Licence, unless the Institute expressly decides otherwise.
5. Special volumes may have a separate price, separate availability scope, separate sales terms or separate licence restrictions if this follows from the nature of the publication.

12. Relationship to other licences

1. The Team / Departmental Licence is a multi-user licence, but limited to the indicated user limit and organisational scope.
2. If the publication is to be made available in a library, reading room, library catalogue or library resource, the Library Licence may be appropriate.
3. If the publication is to be used in teaching, classes, seminars, academic courses or educational systems, the Academic / Teaching Licence may be appropriate.
4. If the publication is to be used in a large organisation, company, fund, public administration, international organisation or strategic activity, the Corporate / Strategic Licence may be appropriate.
5. If the publication is to be used by more than 10 users, individual pricing or a separate extended licence is required.
6. If the Licensee is unsure which licence is appropriate for the planned manner of use, the Licensee should contact the Institute before purchasing or before commencing use beyond the scope of the Team / Departmental Licence.

13. Breach of licence

1. A breach of the Team / Departmental Licence is any use of the publication beyond the scope defined in this document, the offer description or an individual agreement.
2. A breach of the licence includes in particular:
 - a) making the publication available to an unauthorised person,
 - b) sending a PDF file to an unauthorised person,
 - c) exceeding the user limit,
 - d) using rotational access to circumvent the user limit,
 - e) placing the publication in a repository, intranet, team resource or system accessible to persons outside the scope of the licence,
 - f) making the publication available on the Internet,

- g) removing markings from the digital copy,
 - h) circumventing technical safeguards,
 - i) using the publication in a manner appropriate for an extended licence without obtaining such a licence,
 - j) disseminating substantial parts of the publication,
 - k) presenting the methodology, models, structures or conclusions of the Institute as one's own,
 - l) using the publication to train artificial intelligence models or create databases without the consent of the Institute,
 - m) creating material that substitutes the publication,
 - n) using the Team / Departmental Licence as apparent team access while the publication is in fact used by a greater number of persons than the permitted limit.
3. In the event of a breach of the Team / Departmental Licence, the Institute may in particular:
- a) revoke access to digital publications,
 - b) block access to user accounts or the digital reading room, if such a technical solution is used,
 - c) refuse to sell further publications,
 - d) refuse participation in support programmes,
 - e) refuse to grant further licences,
 - f) demand the purchase of the appropriate extended licence,
 - g) pursue copyright protection,
 - h) seek damages or other claims provided for by law.
4. Revocation of access due to a breach of the licence does not create an obligation to refund the price of the publication, the subscription price or any other fees paid by the Licensee.
5. The Institute may call upon the Licensee to cease the breach, provide explanations, indicate the source of the breach, confirm the removal of unauthorised copies of the publication or regularise the scope of the licence.
6. Failure by the Licensee to respond to the Institute's notice may be regarded as a circumstance aggravating the breach of the licence.

14. Liability of the Licensee

1. The Licensee is responsible for the manner of using the publication covered by the Team / Departmental Licence.
2. The Licensee should secure the digital file against access by unauthorised persons.

3. The Licensee is responsible for complying with the user limit.
4. The Licensee is responsible for the actions of Authorised users in the scope of using the publication.
5. The Licensee is responsible for making the publication available to third parties if this occurred as a result of an act, omission, negligence or improper safeguarding of the file by the Licensee, its employees, associates, representatives, users or persons acting on its behalf.
6. The Licensee should promptly inform the Institute of the loss of a file, unauthorised access, suspected licence breach or disclosure of the publication to third parties.
7. The Licensee is not liable for breaches resulting solely from causes attributable to the Institute or from actions of third parties over whom the Licensee had no control, provided that the Licensee exercised due care in safeguarding the publication.

15. Amendment of licence terms

1. The Institute may amend these licence terms, in particular in the event of changes in law, changes in the method of distribution of publications, launch of a digital reading room, changes in technical safeguards, changes in the licence structure or the need to clarify the rules for using publications.
2. The amended licence terms apply to publications purchased after the date of entry into force of the new terms, unless applicable law or the offer description provides otherwise.
3. In the case of subscriptions active on the date of amendment of the terms, the new terms may apply to volumes made available after the date of amendment, provided that this does not infringe the Licensee's acquired rights to publications already made available.
4. The current version of the licence terms is published on the Institute's website or made available together with the publication.

16. Final provisions

1. In matters not regulated by this document, applicable law and the relevant regulations of the Institute shall apply.
2. If any provision of these terms proves invalid, ineffective or impossible to perform, this shall not affect the validity of the remaining provisions.
3. In the event of any discrepancy between this document and an individual agreement concluded with the Licensee, the provisions of the individual agreement shall prevail.
4. In the event of any discrepancy between this document and the description of a specific offer, the offer description shall prevail to the extent that it grants the Licensee broader rights or defines special access conditions.
5. The Team / Departmental Licence applies from the moment of purchasing the publication, obtaining access to the publication or commencing a subscription in the Team /

Departmental variant, unless the offer description provides otherwise.

6. These licence terms enter into force on the date of their publication on the Institute's website.
